## **FAQS**

### **Why would I apply for financial assistance?**

Financial assistance is available to families who are not eligible for CHOICE, or if you are applying after the choice deadline. If you qualify for WI Choice and you decline, you are not eligible for AJA Financial Assistance.

### **What discounts are available?**

Tuition discount is based on size of family and income, similar to CHOICE. Discounts are available from 30%-90%.

### **Is there a deadline to Apply for AJA Financial Assistance?**

By May 20th. This will provide the time needed for AJA staff to prepare for your child. However, there are exceptions for special circumstances such as just moving to the area.

### **Are there limited funds available?**

The funds that are available for financial assistance are made possible by generous donations from Wisconsin Seventh-Day Adventist Church members. The mission of the AJA school board is to distribute these funds to families as a collaborative effort to offer Christ-centered education for all students.

### **Do I need to be a member of the Seventh Day Adventist Church to apply?**

No! All families who are seeking a Christ-centered education for their children are welcome to apply.

### **What are the steps?**

Step 1: Fill out the Financial Application at the time of application and submit online or turn in to office. Be sure to submit proof of income.

Step 2: Meet with Principal & Treasurer.

## Household Calculator

### **\*What factors determine family size and income eligibility?**

A family is a group of two or more people who reside together as part of the same household and who are related by birth, marriage, or adoption. Family size includes parent(s) on the application and their children by birth, marriage, or adoption, who reside in the same household as the student applicant(s).

If a student's parents are divorced or separated and living in the same residence, the above information determines which parent may complete the application for the student. As both parents reside in the same residence as the student, both parent names must be included on the application when determining income eligibility.

If the parent that completes the application is remarried, the parent and his or her spouse that reside in the same household would be included on the application and the income of both the parent and the parent's spouse would be included for the income eligibility determination regardless if the new spouse has legally adopted the student.

## Financial Assistance: Income Calculator

**Instructions: If both parents file taxes separately and live in the same household; please enter total from both tax returns. A copy of the 1040's will be required upon final approval.**

Enter AGI, Line 11 from all eligible Federal Tax Forms 1040:

**If a student's parent lives with a significant other, and they are not married, should their income be included?**

A parent is defined as a biological parent, a parent by adoption, or a step-parent that resides at the same address as the student applicant and his or her income would be included for the income eligibility determination. To be included as a step-parent the person must be married to the student applicant's parent and reside at the same address as the student applicant.
